The product is exposed to the pressure of the molding material with the effect that the ferrite body is possibly damaged by this pressure and so the electrical as well as the mechanical characteristics are endangered to be affected. After the molding material is cured, the ferrite body of the product has to be checked if any reduced electrical or mechanical functions or destructions have occurred.
